An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

23-25 Gordon Street

Proposal:

The applicant is proposing to construct a third-storey addition to the existing building for an emergency shelter.

By-Law Requirements:

The property is located in the Specialized Downtown 1 (D.1-20) Zone. A variance from Section 4.29.1 of Zoning By-law (1995)-14864, as amended, is being requested. The By-law requires that the maximum occupancy for an emergency shelter shall be limited to a maximum of 16 beds.

The property is also located in the Site-specific Downtown 1 (D.1-18) Zone. A variance from Table 5.4 Row 7 of Zoning By-law (2023)-20790, as amended, is being requested. The By-law requires that the minimum number of required off-street parking spaces be 1.5 per 100 metres square of gross floor area [22 spaces] for a community use.

Request:

The applicant is seeking relief from the requirements of Zoning By-law (1995)-14864, as amended, to permit a maximum of 75 beds in the existing emergency shelter.

The applicant is also seeking relief from the requirements of Zoning By-law (2023)-20790, as amended, to permit a minimum of 17 off-street parking spaces.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing.

Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 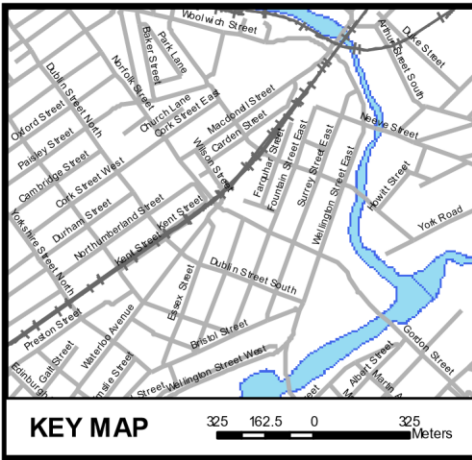
