An Application for Consent [New Lot] has been filed with the Committee of Adjustment

Application Details

Location:

280 Speedvale Avenue West

Proposal:

The applicant is proposing to sever a portion of the property that is currently vacant and create a new industrial lot with one retained lot. The proposed retained lands currently contain a single-storey industrial building, and no changes are proposed to the retained lands.

By-Law Requirements:

The property is located in the Industrial (B.3) Zone, according to Zoning By-law (1995)-14864, as amended. The property is also located in the Industrial (B) Zone, according to Zoning By-law (2023)-20790, as amended.

Request:

The applicant proposes to sever a parcel of land with frontage along Speedvale Avenue West of 52.68 metres and an area of 8,455 square metres. The retained parcel will have frontage along Speedvale Avenue West of 150.66 metres and an area of 23,422 square metres.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 53 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of

Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 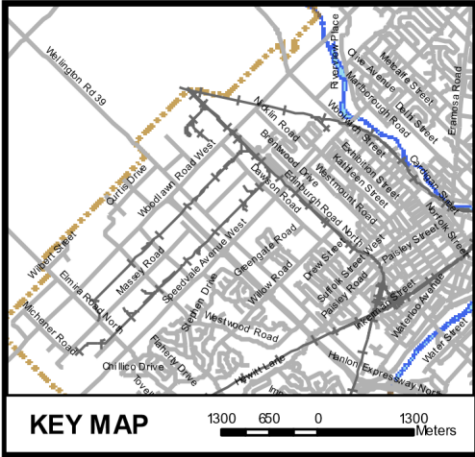
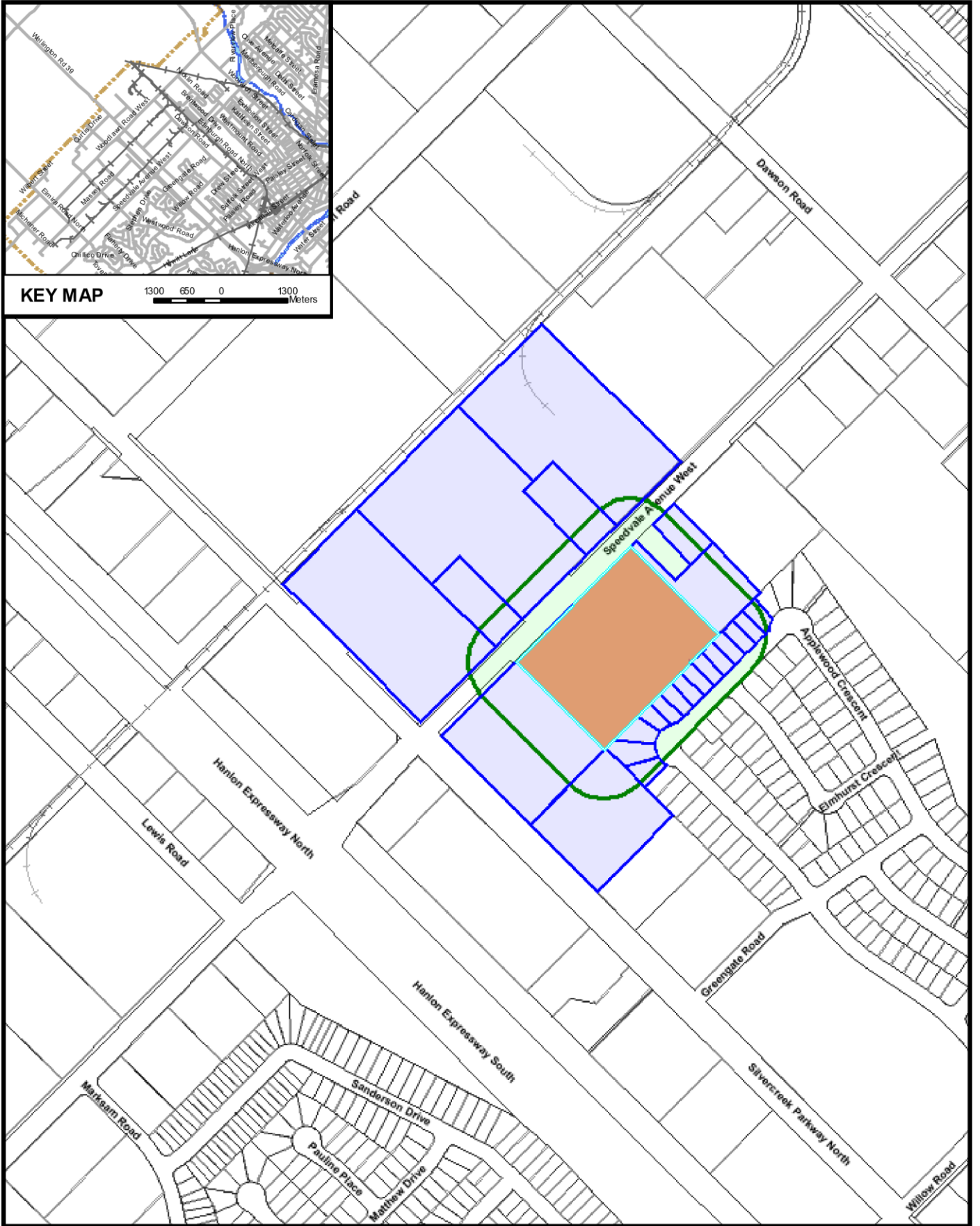
