An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

1888 Gordon Street

Proposal:

The applicant is in the process of constructing a multi-unit residential apartment building alongside the two existing apartment buildings on the subject property. The total number of residential dwelling units proposed for the site will be 526.

By-Law Requirements:

The property is located in the Specialized Residential Apartment (R.4B-20) Zone. A variance from Sections 4.13.4.3 and 4.13.6 of Zoning By-law (1995)-14864, as amended, is being requested. The By-law requires that, in addition to the requirements of Section 4.13.4.3, a minimum of 20% of the calculated total required number of parking spaces shall be provided for the use of visitors to a residential building [being 135 parking spaces].

The property is also located in the Site-specific High Density Residential 7 (RH.7-7(PA)) Zone with a Parking Adjustment. A variance from Table 5.3 Row 2 of Zoning By-law (2023)-20790, as amended, is being requested. The By-law requires that a minimum of 20% of the required parking spaces shall be for the use of visitor parking [being 135 parking spaces].

Request:

The applicant is seeking relief from the requirements of both Zoning By-laws to permit a minimum of 78 visitor parking spaces for all three apartment buildings located on the subject property.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing.

Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 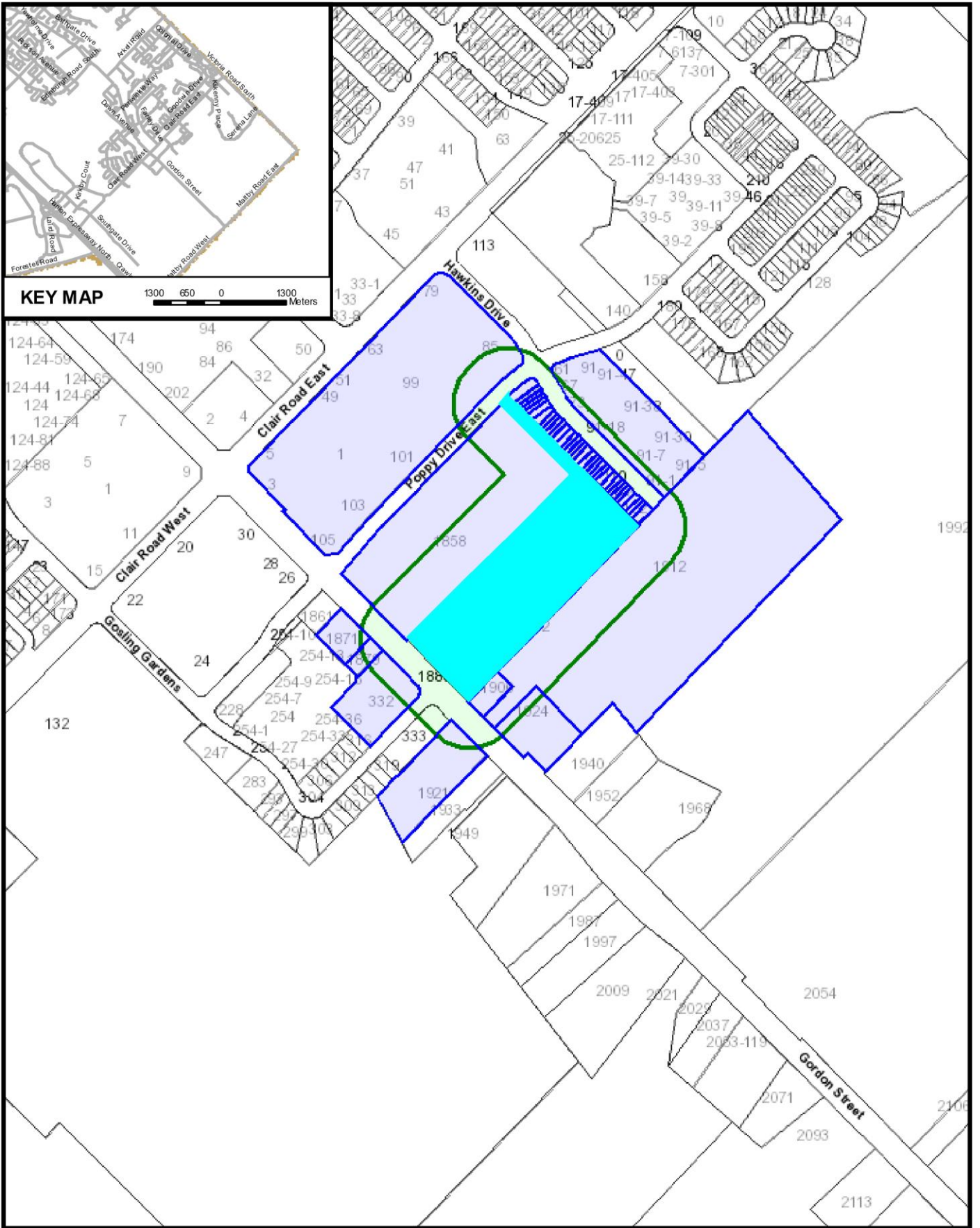
