An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

280 Speedvale Avenue West

Proposal:

The subject property recently received conditional consent approval (file B-1/23) to create a new lot with one retained lot at the January 11, 2024 Committee of Adjustment hearing. One of the conditions of consent approval requires the applicant to receive approval for a minor variance for the buffer strip on the retained lands. The retained lands currently contain a single-storey industrial building, and no changes are proposed to the retained lands.

By-Law Requirements:

The property is located in the Industrial (B.3) Zone of Zoning By-law (1995)-14864, as amended.

The property is also located in the Industrial (B) Zone. A variance from Table 10.3 of Zoning By-law (2023)-20790, as amended, is being requested. The By-law requires a minimum 3 metre wide buffer strip adjacent to interior side and rear lot lines.

Request:

The applicant is seeking relief from the requirements of Zoning By-law (2023)-20790, as amended, to permit a minimum 0 metre wide buffer strip adjacent to the left side yard lot line.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.
