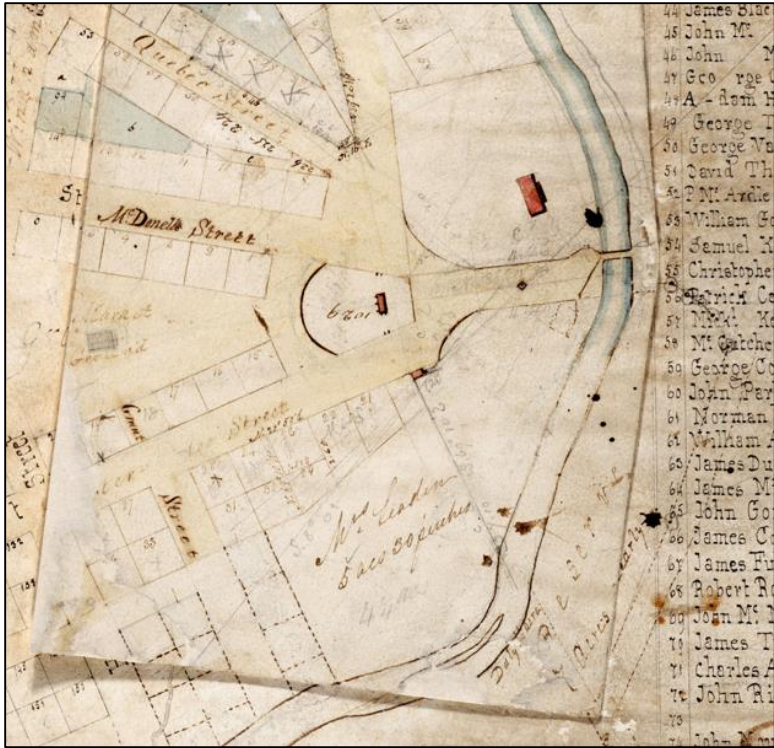


Figure 1: 1828 Plan for Guelph. Area that will become Neeve Street is between mill lands and a large area attributed to William Leadon, 5 acres 30 perches.

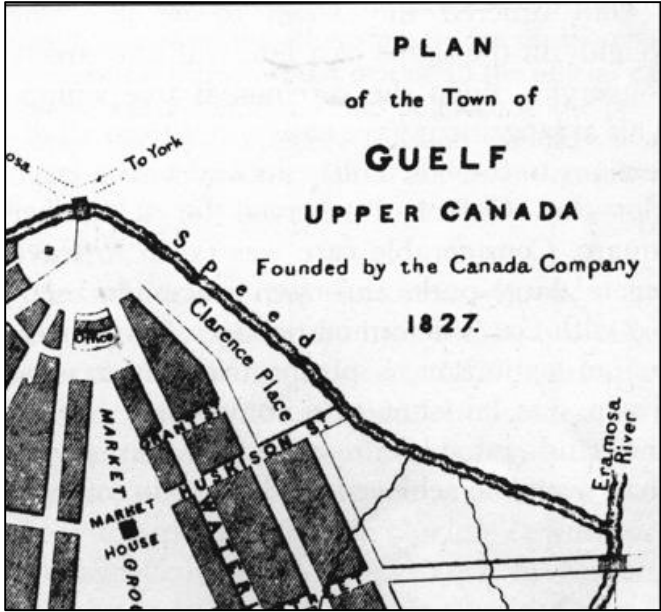


Figure 2 Galt Plan, 1828. Neeve area contained within area labelled 'Clarence Place'

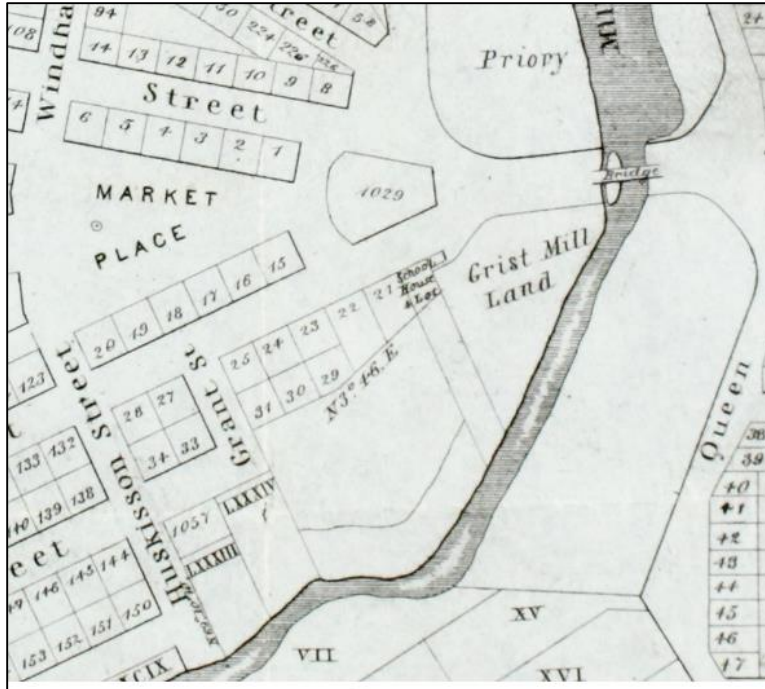


Figure 3: McDonald Plan 1847. Neeve Street is yet to be laid out between Grant Street and the mill lands. Note the lands laid out for a school, to the north-east of where Lots 3 and 4 will eventually be laid out.

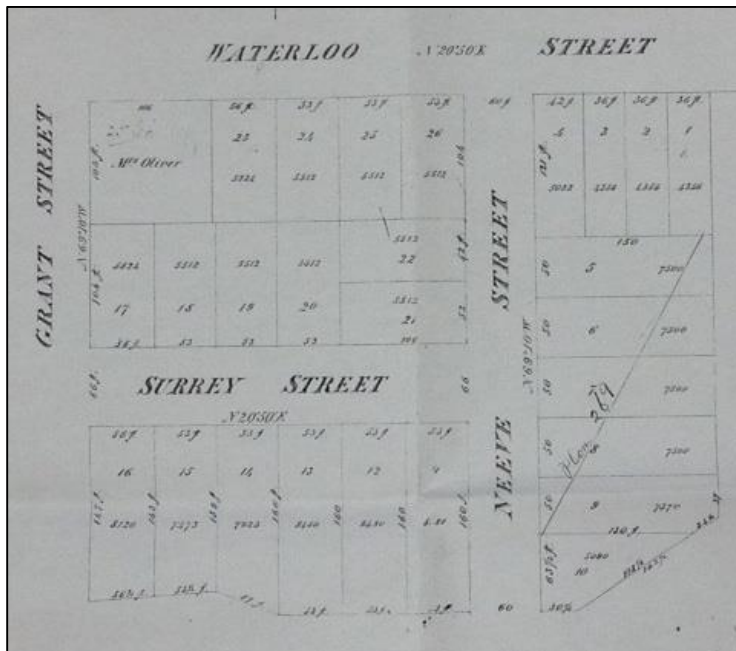


Figure 4: Neeve Map, c. 1855. Plan 33 of Lots on Neeve Street and surrounding neighborhood, from Allan Neeve's map, circa 1855. Note that Lots 3 and 4 will move following the later extension of Surrey Street.

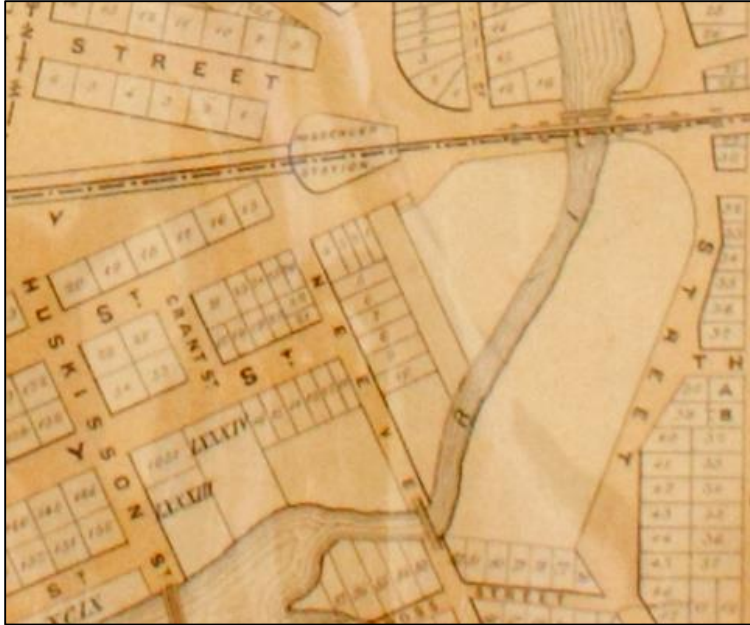


Figure 5: J. Smith Map from 1855. Neeve Street laid out, with Lots 3 and 4 in question now discernible. Note that one Fred J Chadwick is responsible for drawing this map, who is the eventual grantor of lands to Francis Law (the builder of the stone house) and will later become an Alderman.



Figure 6: Hobson and Chadwick Map, 1858. Again, Neeve St. takes shape, with individual lots discernible.

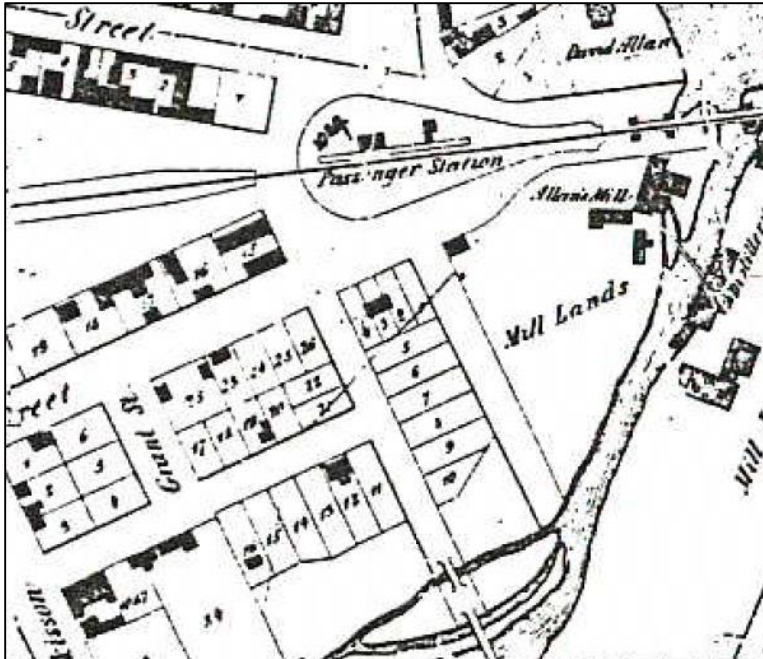


Figure 7: 1862 Plan of Guelph. Note the presence of a large building northwest above where stone house will be built. Note the construction of the passenger station, which Francis Law played a role in constructing.

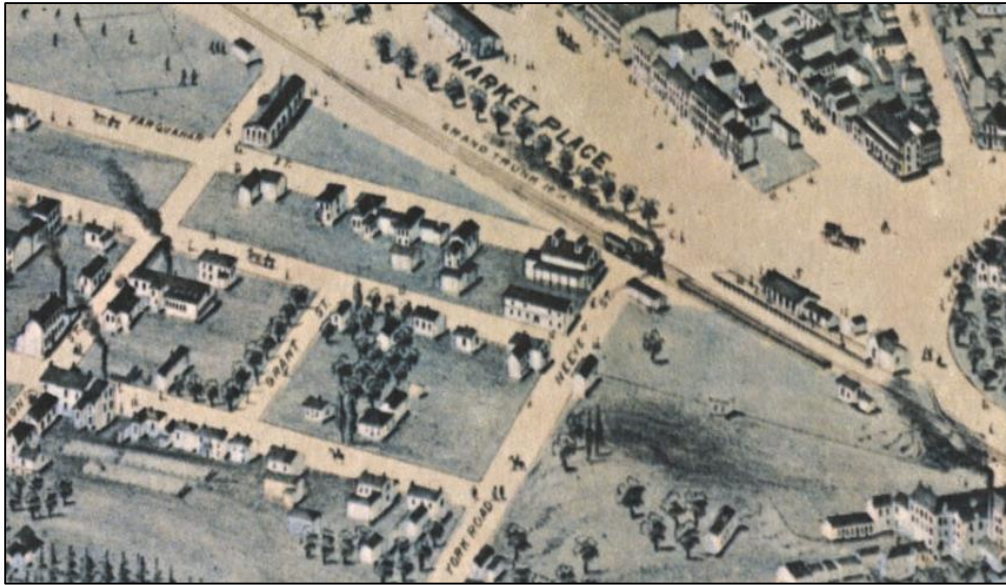


Figure 9: Brosius Birdseye Map, 1872. Development of lands between Neeve Street and 'Mill Lands' is sparse, with the stone house in question still 6 years from construction.



Figure 10: Cotterell Map, 1877. Surrey street has yet to be extended in 1877, as laid out in Plan 269.

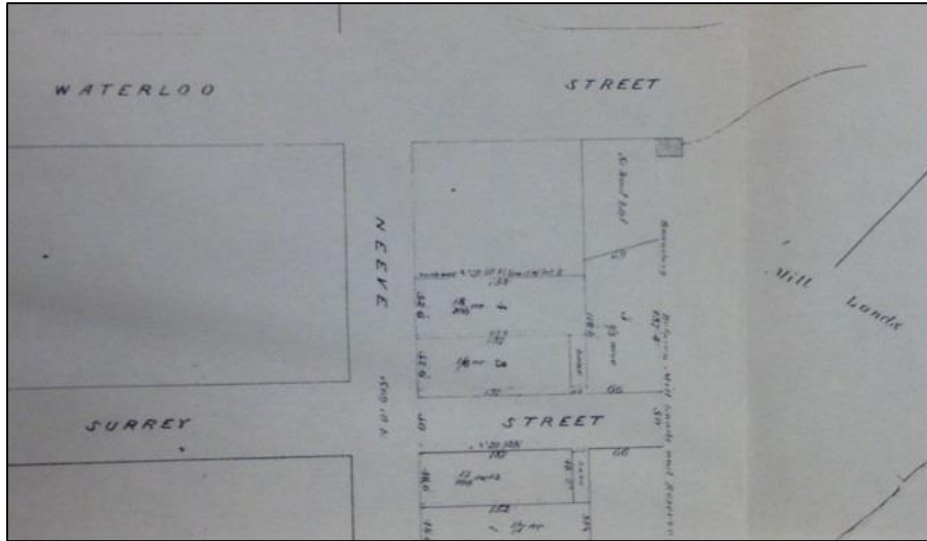


Figure 11: Plan 269 of 14 Neeve Street, as seen in Cooper's Survey circa 1877. Note that an extension to Surrey Street has been proposed, and lots 3 and 4 have moved to where lots 5 and 6 were.

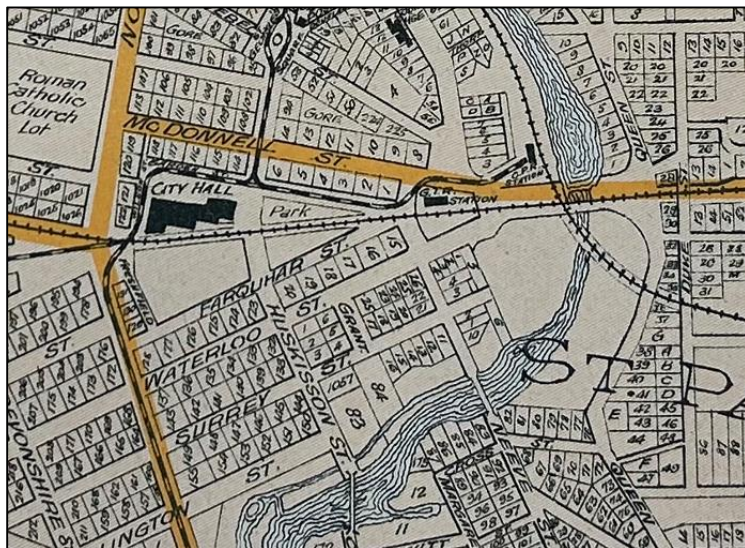


Figure 12: Area of downtown Guelph, Allan's Mill lands, and Neeve Street from 1906 Atlas.

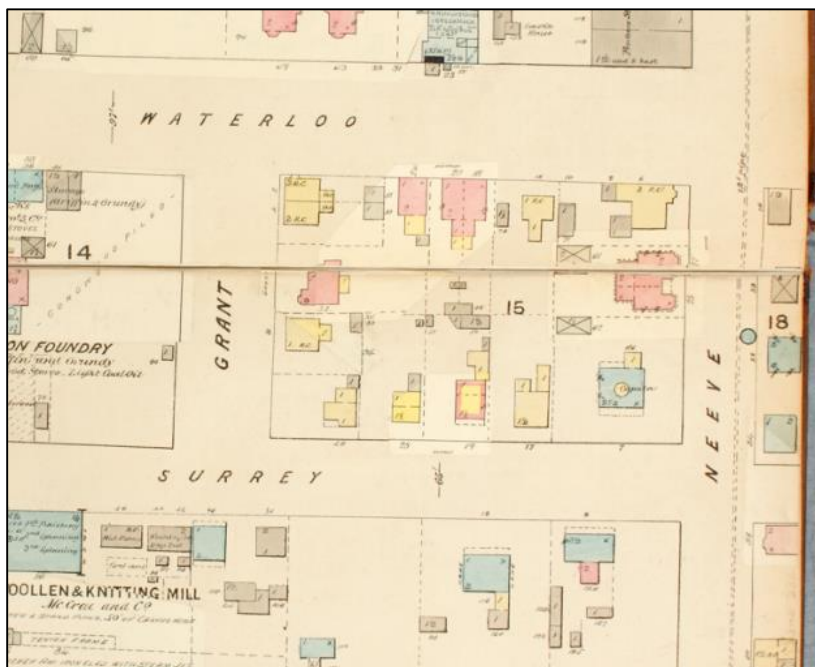


Figure 5: Detail from Fire Insurance Plan 1881 (Revised 1892), Sheet 3. Both 14 Neeve Street and its neighbour on the corner of Neeve and Surrey are now built.

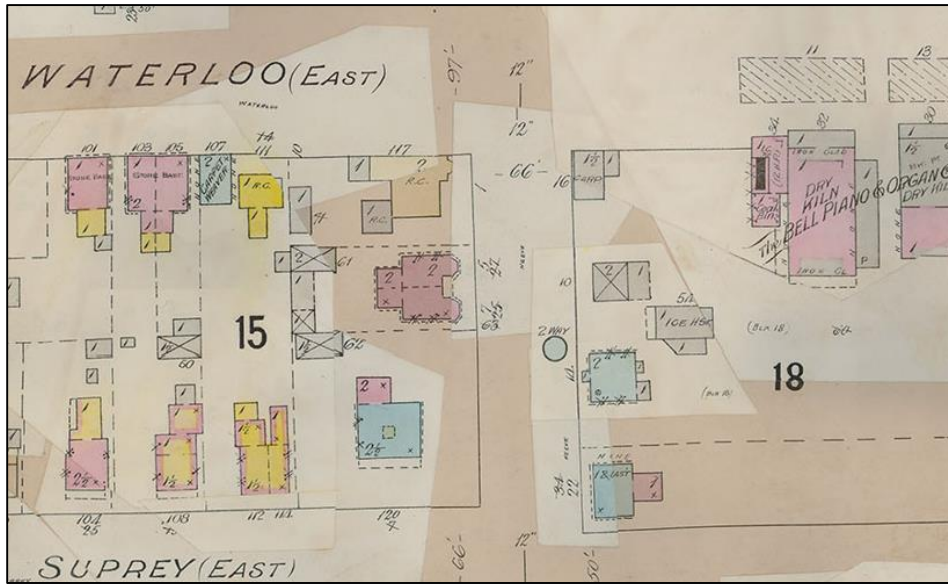


Figure 9: Fire Insurance Plan 1897 (Revised 1911), Sheet 2A.

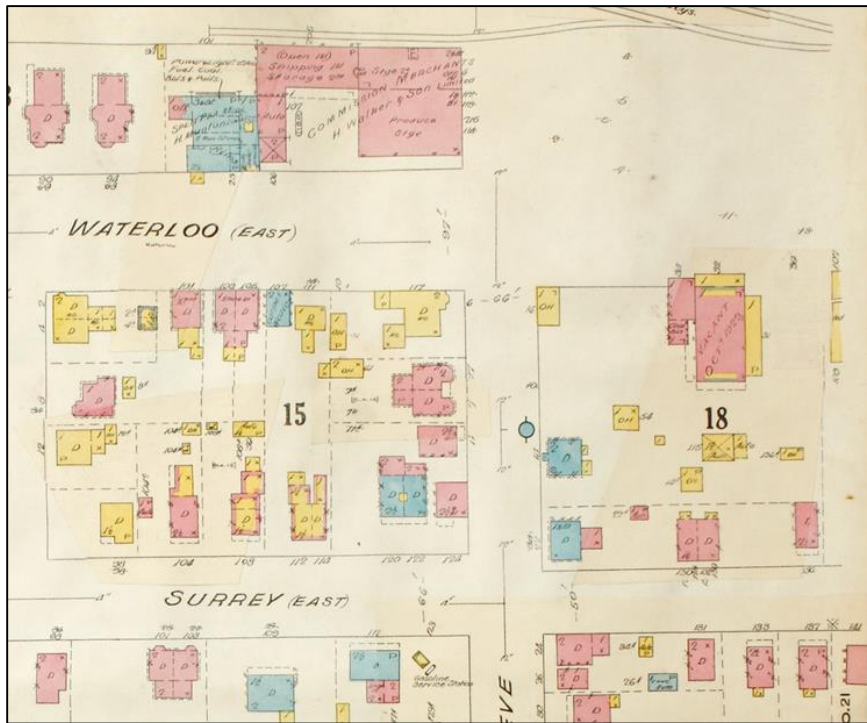


Figure 19: Fire Insurance Plan for 1922 (Revised 1929), Sheet 20.

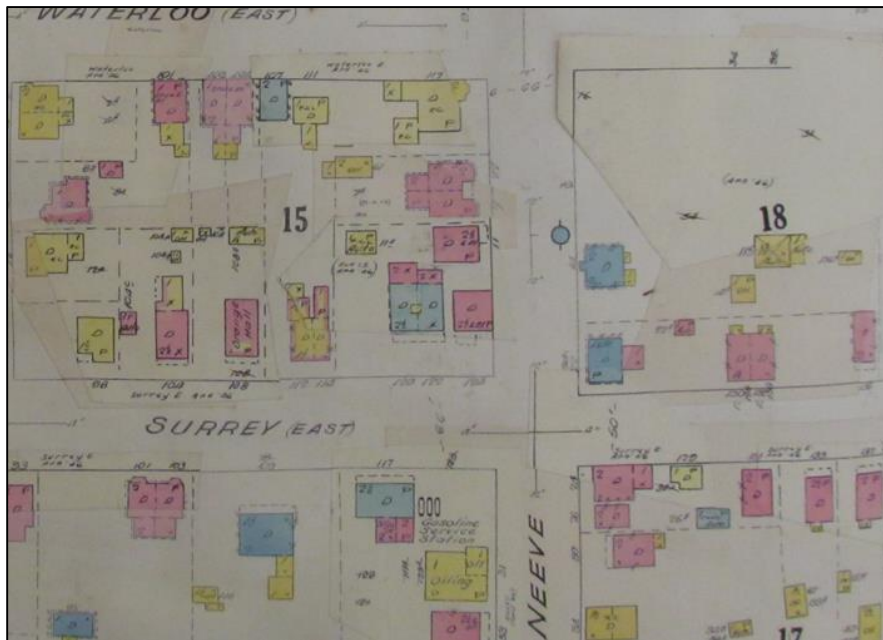


Figure 20: Fire Insurance Plan 1922 (Revised 1946), Sheet 20a.

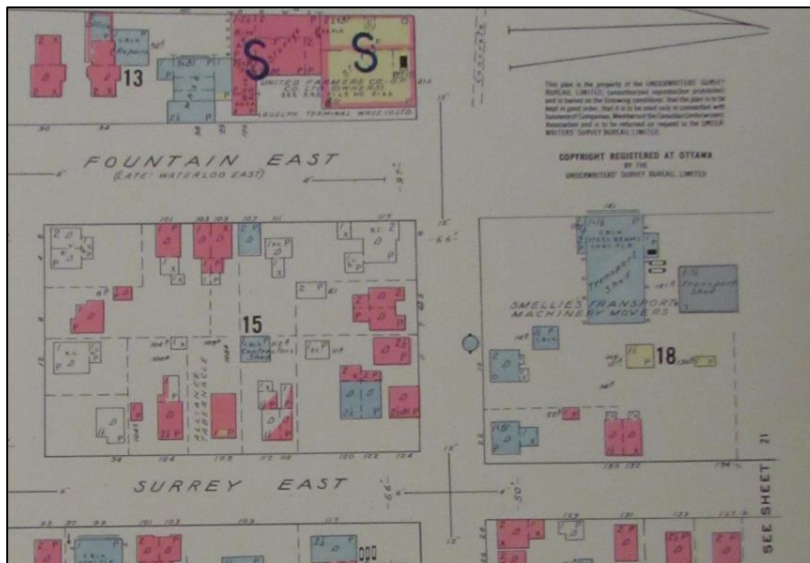


Figure 21: Fire Insurance Plan for 1960, Sheet 20.
