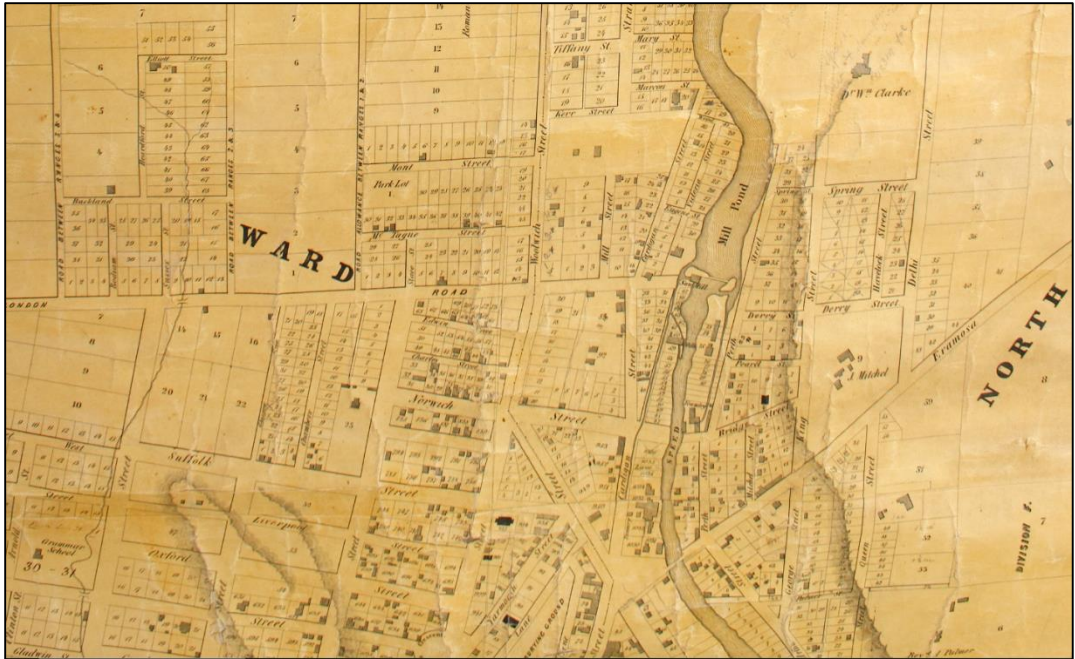


Figure 1: Cooper's Map 1862, Mitchel and Clarke farms.

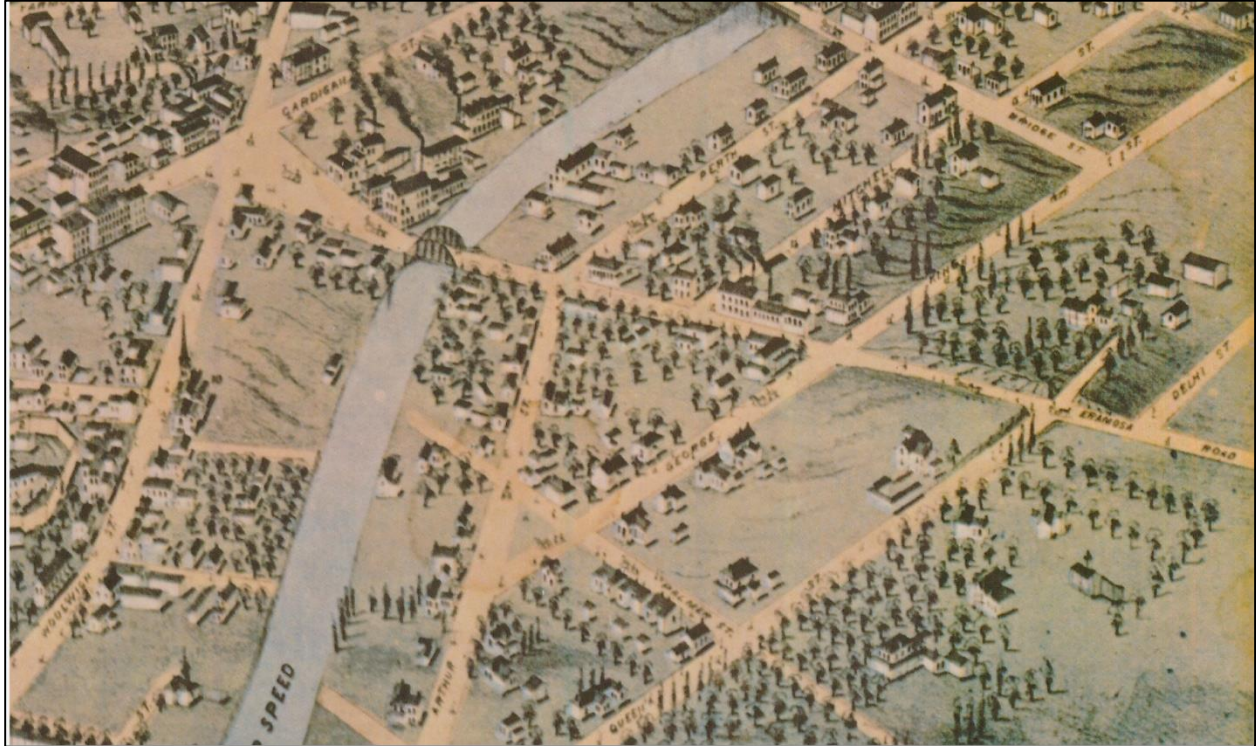


Figure 2: Brosius's Birds Eye View Sketch of city of Guelph showing Mitchell farm between Delhi and King Streets

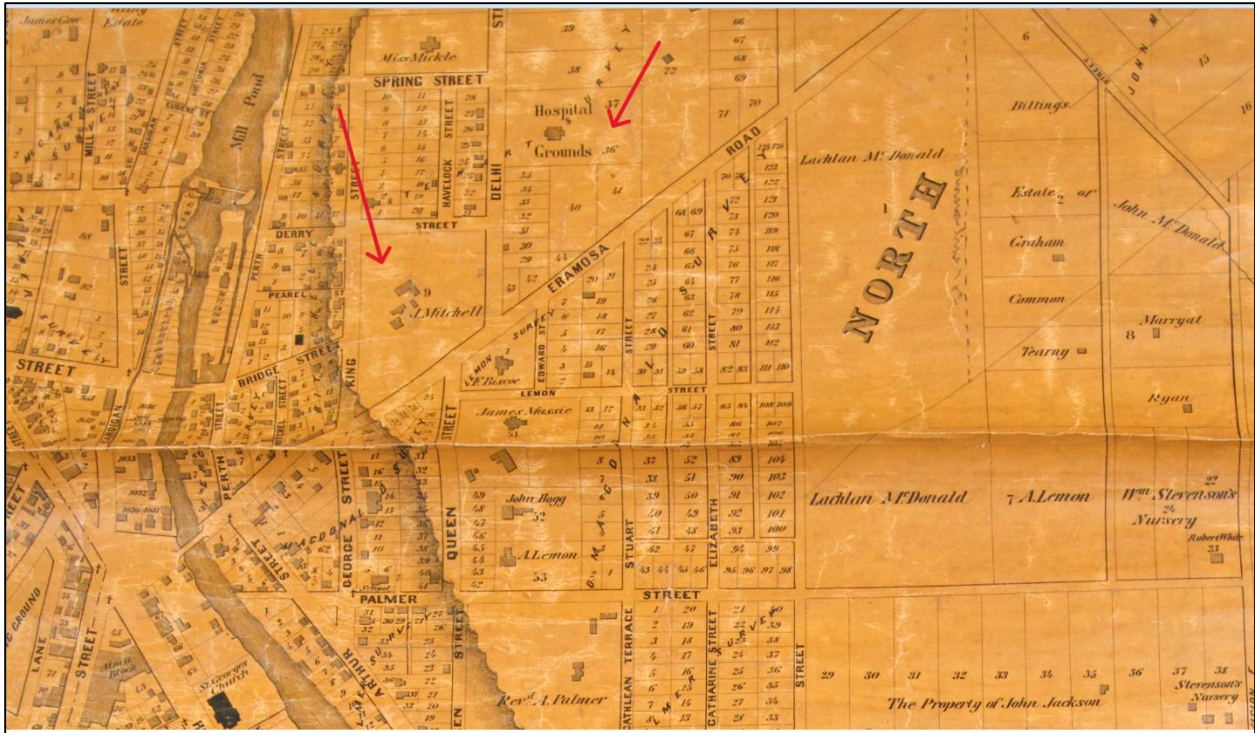


Figure 3: Coopers Map 1875 showing Mitchell farm and Guelph General Hospital Grounds

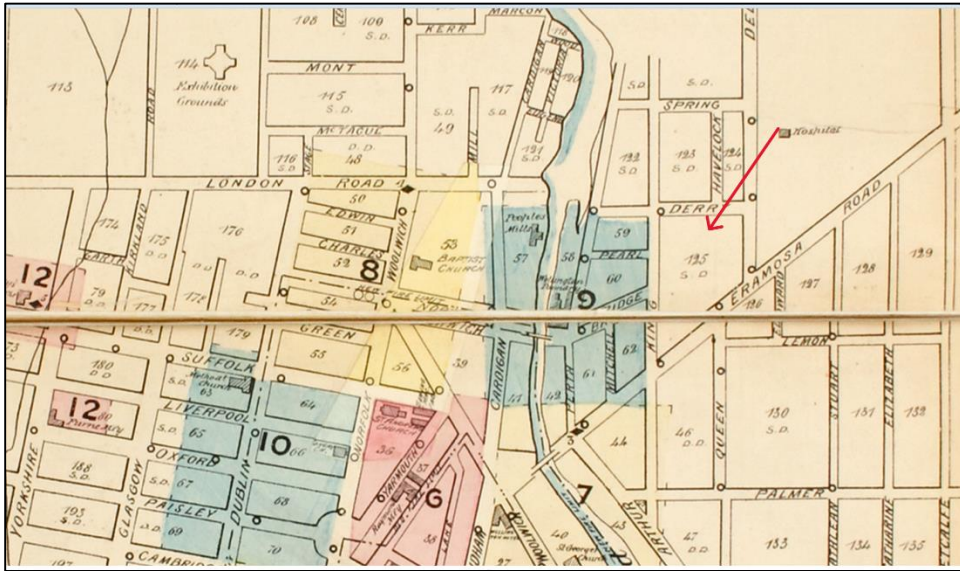


Figure 5: Fire Insurance Plan 1892, property is noted as S.D. = Scattered

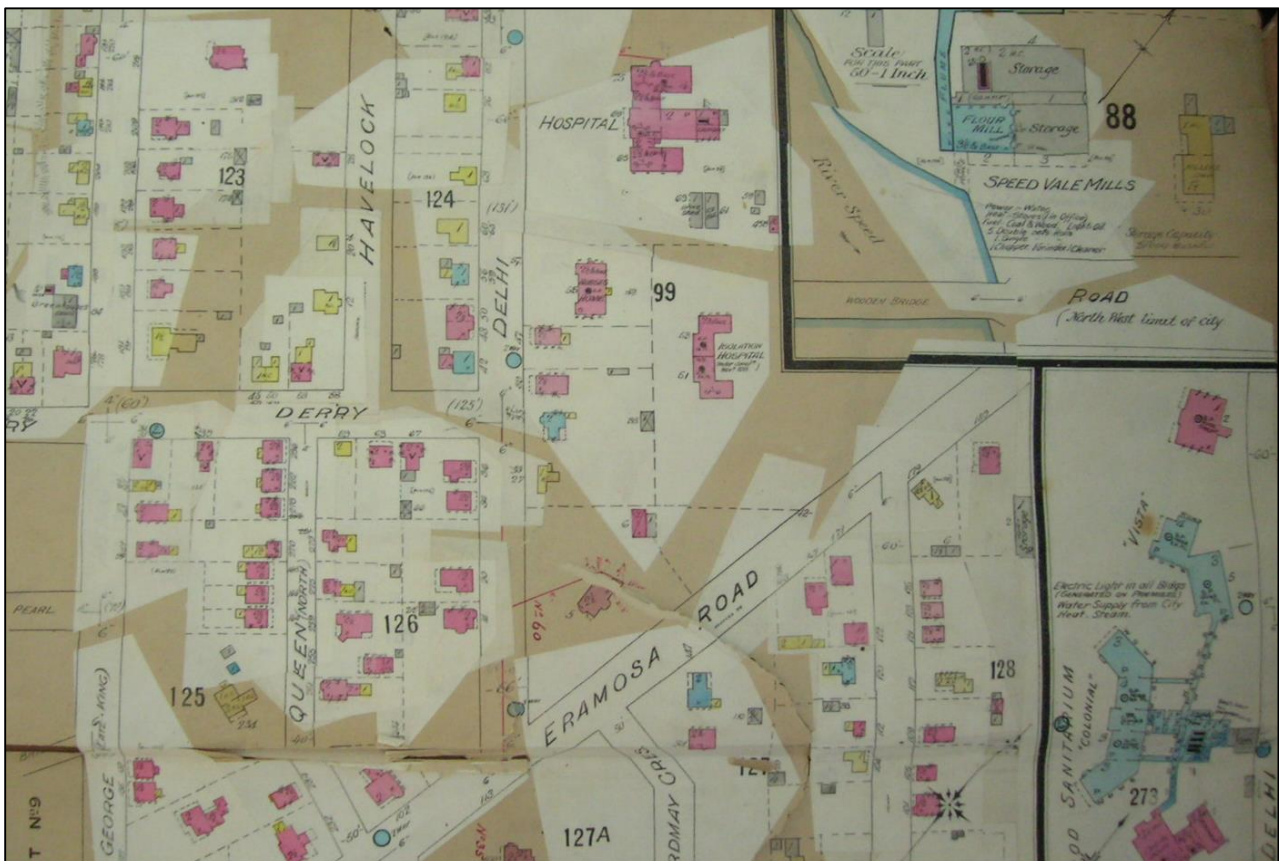


Figure 6: FIP was originally created in 1897 and revised twice: 1907 and 1916. This is the first time a new home structure appears on a fire insurance plan on the lot of the old Mitchell farm. This lists the address as 232 Queen St, not 100 as it is now identified.

**Guelph Doctor's Widow
Prominent in District**

Guelph, Feb. 11 (Special).—Mrs. Alice Thompson Wells died yesterday at Guelph General Hospital after a brief illness. She was the widow of the late Dr. Edward Huger Wells, who died in 1903.

Born in Guelph Township, Mrs. Wells lived on the farm now owned by her nephew, Major E. V. Thompson, near Marden. She and her husband came to Guelph nearly 55 years ago. They were married in St. George's Church in 1897.

A staunch Conservative, Mrs. Wells was active in the Guelph Humane Society and the Imperial Order Daughters of the Empire.

Mrs. Frederic Watt, wife of Guelph's police magistrate, is a niece, as are Mrs. T. G. Griffith, Palm Springs, Cal., and Miss Constance Thompson, Stratford. George Edwin Thompson of Stratford is a nephew.

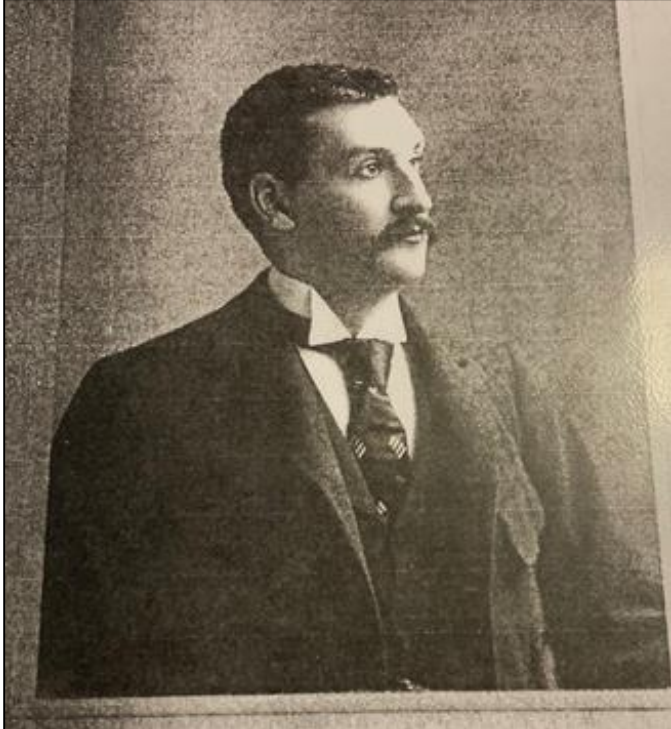


Figure 12 Portrait of Dr. Edward H. Wells

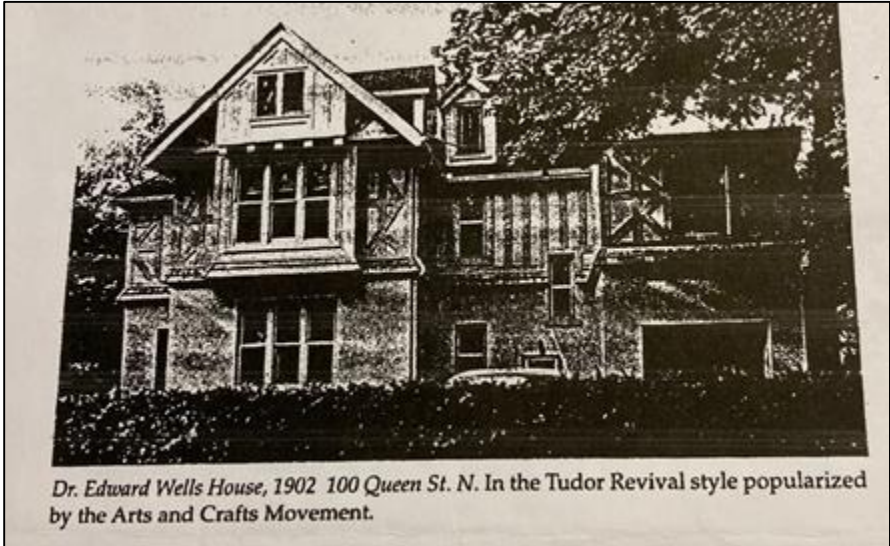


Figure 13 Dr. Edward Wells House, c. 1960

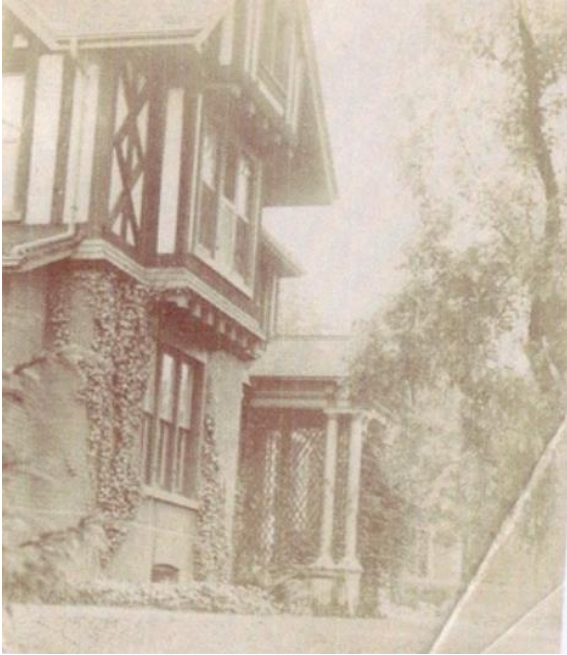


Figure 14: Photograph of the east elevation of 100 Queen, early 20th century (Photograph courtesy of Miranda Corman)
