## The Corporation of the City of Guelph

## By-law Number (2024) - 20957

A by-law to amend the Traffic and Parking By-law Number (2022) – 20698, as amended, being a By-law to regulate the use of Highways within the City of Guelph and the Traffic and Parking thereon

**Whereas** subsection 10(2) paragraph 7 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended ("Act"), provides that a municipal may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

**And whereas** subsection 5(3) of the Act provides that a municipal power shall be exercised by by-law;

**And whereas** the Municipal Council for The Corporation of the City of Guelph ("City") enacted the Traffic and Parking y-law Number (2022) - 20698, as amended ("By-Law (2022) - 20698") to regulate traffic and parking in the City of Guelph;

**And whereas** the City wishes to amend Schedule C to By-law Number (2022)-20698 - Prohibited U Turns and Schedule Y to By-law Number (2022)- 20698 - No Parking Zones of By-law Number (2022)- 20698;

## The Council of the Corporation of the City of Guelph enacts as follows:

- 1. Schedule C to By-law Number (2022) 20698 Prohibited Turns is hereby deleted and replaced with the new Schedule C to By-law Number (2022) 20698 Prohibited Turns, attached hereto as Schedule 1. (To add Florence Lane at Kingsmill Avenue, South, Right, Anytime; To add Florence Lane at Menzie Avenue, South, Right, Anytime; To add Florence Lane at Audrey Avenue, South, Right, Anytime; To add Florence Lane at Lawrence Avenue, South, Right, Anytime; in the Prohibited Turns Schedule).
- 2. Schedule Y to By-law Number (2022) 20698 No Parking Zones is hereby deleted and replaced with the new Schedule Y to By-law Number (2022) 20698 No Parking Zones attached hereto as Schedule 2. (To remove Hill Trail, West, Grange Road to Esker Run, Anytime; To add Hill Trail, East, Grange Road to Esker Run, Anytime; To add Ridgeway Avenue, Both, Arkell Road to Malvern Crescent, Anytime; To add Duck Lane, Both, Hall Avenue to Dominion Lane, (8am to 4pm, Monday to Friday from September 1 to June 30); in the No Parking Zones Schedule).
- 3. This By-law shall come into force and effect on the date that it is passed.
- 4. Notwithstanding section 3, no portion of this By-law shall come into effect until the part of the Highway (as defined in By-law Number (2022) 20698) affected by it has all traffic control devices in place and is marked to comply with the signing requirements of the Ministry of Transportation of Ontario's Ontario Traffic Manuals
- 5. In all other respects By-Law (2022) 20698 remains unchanged.
