# **Application Details**

#### **Location:**

25 Aberdeen Street

## **Proposal:**

The applicant is proposing to restore the original roofed front porch with stairs that was previously enclosed.

## **By-Law Requirements:**

The property is located in the Low Density Residential 1 (RL.1) Zone. Variances from Table 4.7.5A of Zoning By-law (2023)-20790, as amended, are being requested.

The By-law requires:

- a) a minimum front yard setback of 2 metres for an open, roofed porch not exceeding 1 storey in height; and
- b) stairs associated with a porch to have a minimum front yard setback of 2 metres.

## **Request:**

The applicant is seeking relief from the requirements of Zoning By-law (2023)-20790, as amended, to permit:

- a) a minimum front yard setback of 1.3 metres for the proposed open, roofed front porch; and
- b) a minimum front yard setback of 0.1 metres for the proposed exterior stairs associated with the proposed open, roofed front porch.
