Century-old home with original front porch (brick columns) was enclosed and wrapped in siding under permit in 2007. The original front porch steps were removed and access was moved to side off drive. Wish to remove old peeling vinyl siding porch and original house layout with front steps in alignment with front door, as shown on historical photos of house. Steps will be approximately 0.1m from the lot line, which is closer than setback distance stated in the Bylaw, which was put into effect after house was constructed. The enclosed porch is not structural - simply plywood and vinyl wrapped around the beautiful old brick pillars (which support the second story of the house). Everything is intact beneath the siding, and wish to remove the ugly white peeling siding to show the original porch and house as exists. There is no structural work or other major work to do on the porch other than putting steps back in front of the main entrance, in the same location as shown in the historical photo and before siding was wrapped around the house. Aberdeen Street is the heart of the Old City, with designated heritage properties within the vicinity. Removing plastic siding to show the house beneath shows the beautiful house in this historic neighbourhood and positively adds to the character of the street and the City.
