

An Application for Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

8 Grant Street

Proposal:

The applicant is proposing to convert the existing detached garage on the subject property into an additional residential dwelling unit (ARDU).

By-Law Requirements:

The property is located in the Downtown 2 (D.2) Zone. Variances from Section 4.12.1(d)(vii) and Section 4.12.1(d)(viii) of Zoning By-law (2023)-20790, as amended, are being requested.

The By-law requires that:

- a) an additional residential dwelling unit in a separate building on a lot shall have a minimum interior side yard and rear yard setback consistent with the interior side yard setback for the primary dwelling unit in the D.2 Zone, being a minimum of 1.5 metres; and
- b) a minimum distance of 3 metres shall be provided between the primary dwelling unit and an additional residential dwelling unit in a separate building on the same lot.

Request:

The applicant is seeking relief from the requirements of Zoning By-law (2023)-20790, as amended, to permit:

- a) a minimum left side yard setback of 0 metres for the proposed additional residential dwelling unit in a separate building on the lot; and
- b) a minimum distance of 2.63 metres between the primary dwelling unit and the proposed additional residential dwelling unit in a separate building on the lot.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.
