Application for Consent [New Lot] has been filed with the Committee of Adjustment

Application Details

Location:

39 Armstrong Avenue

Proposal:

The applicant is proposing to sever the property to create one new residential lot with one retained residential lot. The subject property currently contains an existing dwelling which is proposed to remain, and the existing detached garage is proposed to be removed. A new detached dwelling is proposed to be constructed on the proposed severed lands. Due to the lot reconfiguration, minor variance applications have been submitted for the proposed severed and retained lots (files A-92/24 and A-93/24, see attached).

By-Law Requirements:

The property is located in the Low Density Residential 2 (RL.2) Zone according to Zoning By-law (2023)-20790, as amended.

Request:

The applicant proposes to sever a parcel of land with frontage along Armstrong Avenue of 10.12 metres, a depth of 24.34 metres, and an area of 245 square metres.

The retained parcel will have frontage along Armstrong Avenue of 17.3 metres, a depth of 24.35 metres, and an area of 420 square metres.

Hearing Details

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 53 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 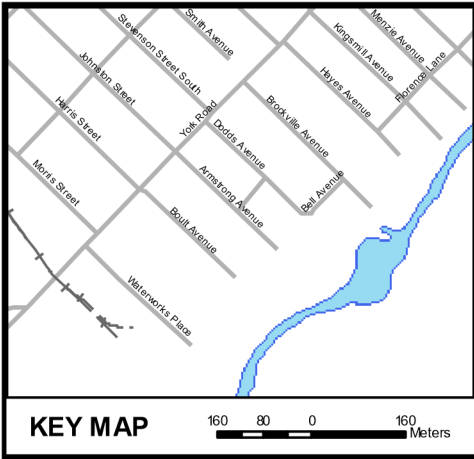
