# **Location:**

### **Proposal:**

The applicant would like to increase the amount of medical clinic uses in the existing building, which has a gross floor area of 1,682 square metres.

## **By-Law Requirements:**

The property is located in the Mixed Office/Commercial (MOC)(PA)(H12) Zone with parking adjustment and holding provisions. A variance from Table 7.1 of Zoning Bylaw (2023)-20790, as amended, is being requested.

The By-law requires that within the MOC Zone, medical clinic uses be permitted to a maximum of 400 square metres on a property.

### **Request:**

The applicant is seeking relief from the requirements of Zoning By-law (2023)-20790, as amended, to permit a medical clinic use to a maximum of 1,682 square metres within the existing building.
