

Committee of Adjustment Notice of Public Hearing



An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

68-76 Wyndham Street South

Proposal:

The applicant is proposing to sever the property to create one new residential lot with one retained residential lot. The subject property currently contains two existing dwellings and a detached shed which are proposed to be removed. Multi-unit residential buildings are proposed on both the proposed severed and retained lands. Due to the lot reconfiguration, a consent application has been submitted for the proposed new lot (file B-1/25, see attached).

By-Law Requirements:

The property is located in the Low Density Residential 1 (RL.1) Zone. Variances from Tables 6.3 and 6.2 of Zoning By-law (2023)-20790, as amended, are being requested.

The By-law requires that:

- a) the minimum front yard be 6 metres for a multi-unit residential building located in the RL.1 Zone;
- b) a minimum rear yard of 7.5 metres, or 20 percent of the lot depth, whichever is less, for a multi-unit building in the RL.1 Zone; and
- c) a minimum setback of 0.5 metres between the driveway, residential and the nearest lot line must be maintained as landscaped space in the form of natural vegetation, such as grass, flowers, trees and shrubbery.

Request:

File A-2/25 (Severed Parcel)

The applicant is seeking relief from the requirements of Zoning By-law (2023)-20790, as amended, to permit:

- a) a minimum front yard of 4.5 metres for the proposed multi-unit residential building; and
- a) a 0 metre setback between the driveway and the nearest lot line.

File A-3/25 (Retained Parcel)

- b) a minimum front yard of 4.5 metres for the proposed multi-unit residential building;
- c) a minimum rear yard of 3.75 metres for the proposed multi-unit residential building; and
- d) a 0 metre setback between the driveway and the nearest lot line.

Hearing Details

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 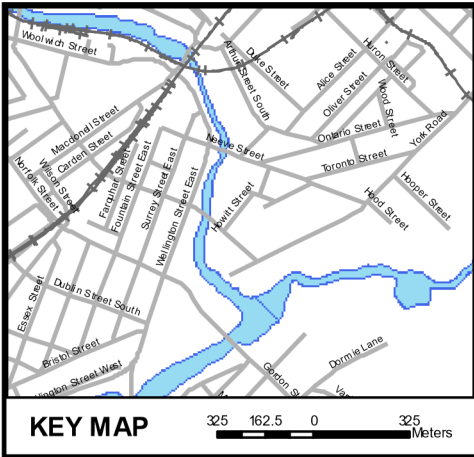
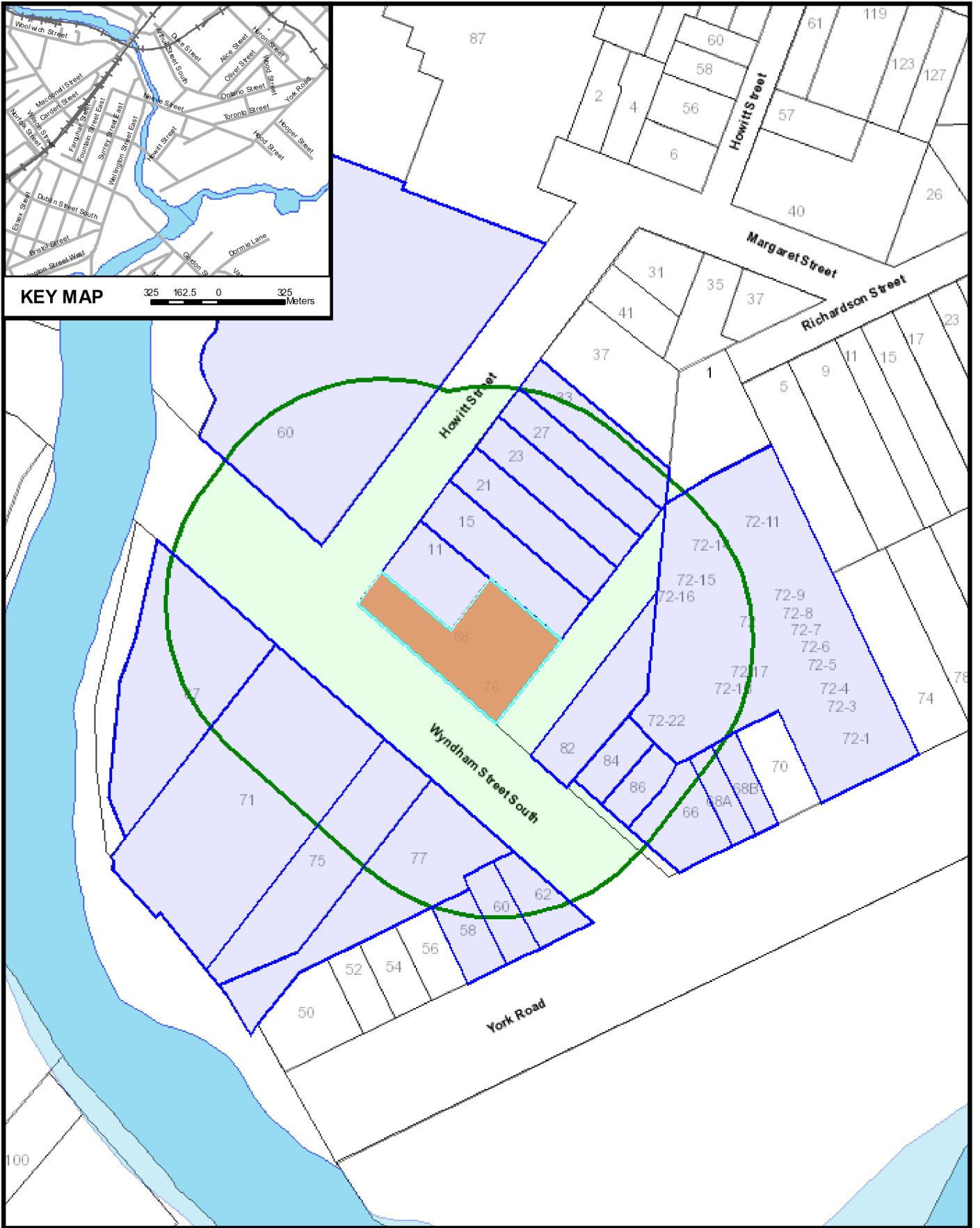
