Application for Consent [New Lot] has been filed with the Committee of Adjustment

Application Details

Location:

79 Northumberland Street

Proposal:

The applicant is proposing to sever the property to create one new residential lot with one retained residential lot. The subject property currently contains an existing dwelling with an addition, and the addition is proposed to be removed. The applicant is proposing to construct a new addition to the existing two-storey dwelling, and construct a new semi-detached residential unit on the severed parcel. Due to the lot reconfiguration, minor variances are required for the proposed severed and retained parcels (files A-10/25 and A-11/25, see attached).

By-Law Requirements:

The property is located in the Low Density Residential 1 (RL.1) Zone according to Zoning By-law (2023)-20790, as amended.

Request:

The applicant proposes to sever a parcel of land with frontage along Northumberland Street of 9.67 metres, and an area of 314 square metres.

The retained parcel will have frontage along Northumberland Street of 9.38 metres, and an area of 304 square metres.

Hearing Details

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 53 of the Planning Act R.S.O. 1990 P.13, as amended.

Please indicate your name, phone number and the application number or address of the property you wish to speak to. When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet.

Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. If a person or public body has the ability to appeal the decision of the City of Guelph Committee of Adjustment in respect to the proposed consent to the Ontario Land Tribunal but does not make written submissions to the City of Guelph Committee of Adjustment before it gives or refuses to give a provisional consent, the Tribunal may dismiss the appeal.

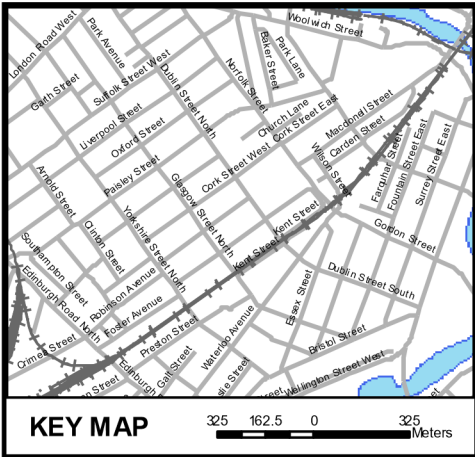
