The Corporation of the City of Guelph

By-law Number (2025) - 21076

A By-law to amend by-law number (2024) – 21002, as amended by by-law number (2025) – 21052, being a by-law to impose user fees or charges for services or activities relating to Public Services, Infrastructure, Development and Enterprise Services, Corporate Services and the Office of the Chief Administrative Officer.

Whereas pursuant to section 391 of the *Municipal Act, 2001* (the "Act"), the Council of The Corporation of the City of Guelph is authorized to pass by-laws imposing fees or charges on persons;

And whereas the Council of The Corporation of the City of Guelph passed by-law number (2025) – 21055, as amended by By-law Number (2025) - 21061, establishing a system of administrative penalties and administrative fees for designated City by-laws, as set out therein from time to time;

And whereas the Council of The Corporation of the City of Guelph has approved a Municipal Service and Financing Agreements Policy to enable the advancement of municipal infrastructure and servicing to enable housing, by application and governed by Municipal Service and Financing Agreements;

And whereas the Council of The Corporation of the City of Guelph passed By-law Number (2025) – 21095, as amended by By-law Number (2025) - 21061, being a by-law to prohibit or regulate the injuring or destruction of trees on private property within the City of Guelph;

The Council of the Corporation of the City of Guelph enacts as follows:

- 1. By-law (2024) 21002 is hereby amended as follows:
- (1) Schedule 1 is amended to add Table 92 (Table 132) Private Tree By-law Fees, Table 93 (Table 133) Municipal Service and Financing Agreement Fees Table, and 94 Court Services Administrative Penalty System Fees, attached to this amending By-law.
- 2. This By-law shall come into force and take effect on the date enacted by Council.
