#### Location:

2162 Gordon Street

### **Proposal:**

The applicant is proposing to sever a part of the property to create a new lot with one retained lot. No changes are proposed to the existing land uses on the severed and retained lands at this time.

## **By-Law Requirements:**

The property is located in the Urban Reserve 1 (UR.1) Zone, according to Zoning By-law (2023)-20790, as amended.

#### **Request:**

The applicant proposes to sever a parcel of land with frontage along Gordon Street of 127.4 metres, a depth of 1,022.6 metres, and an area of 158,496 square metres (15.85 hectares). The retained parcel will have frontage along Gordon Street of 256 metres, a depth of 1,025.5 metres, and an area of 263,173 square metres (26.32 hectares).
