Application for Consent [New Lot] has been filed with the Committee of Adjustment

Application Details

Location:

4 June Avenue

Proposal:

The applicant is proposing to sever the property to create a new lot with one retained lot. The property currently contains an existing dwelling, which is proposed to be demolished. A semi-detached dwelling is proposed to be constructed on the proposed severed and retained lands. Each of the proposed semi-detached dwelling units is proposed to have 1 internal additional dwelling unit, for a total of 4 residential units between the severed and retained parcels.

By-Law Requirements:

The property is located in the Low Density Residential 1 (RL.1) Zone, according to Zoning By-law (2023)-20790, as amended.

Request:

The applicant proposes to sever a parcel of land with frontage along June Avenue of 7.77 metres, a depth of 32 metres, and an area of 248.7 square metres. The retained parcel will have frontage along June Avenue of 7.77 metres, a depth of 32 metres, and an area of 248.7 square metres.

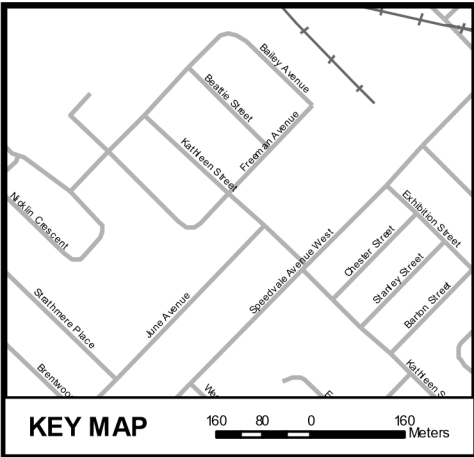
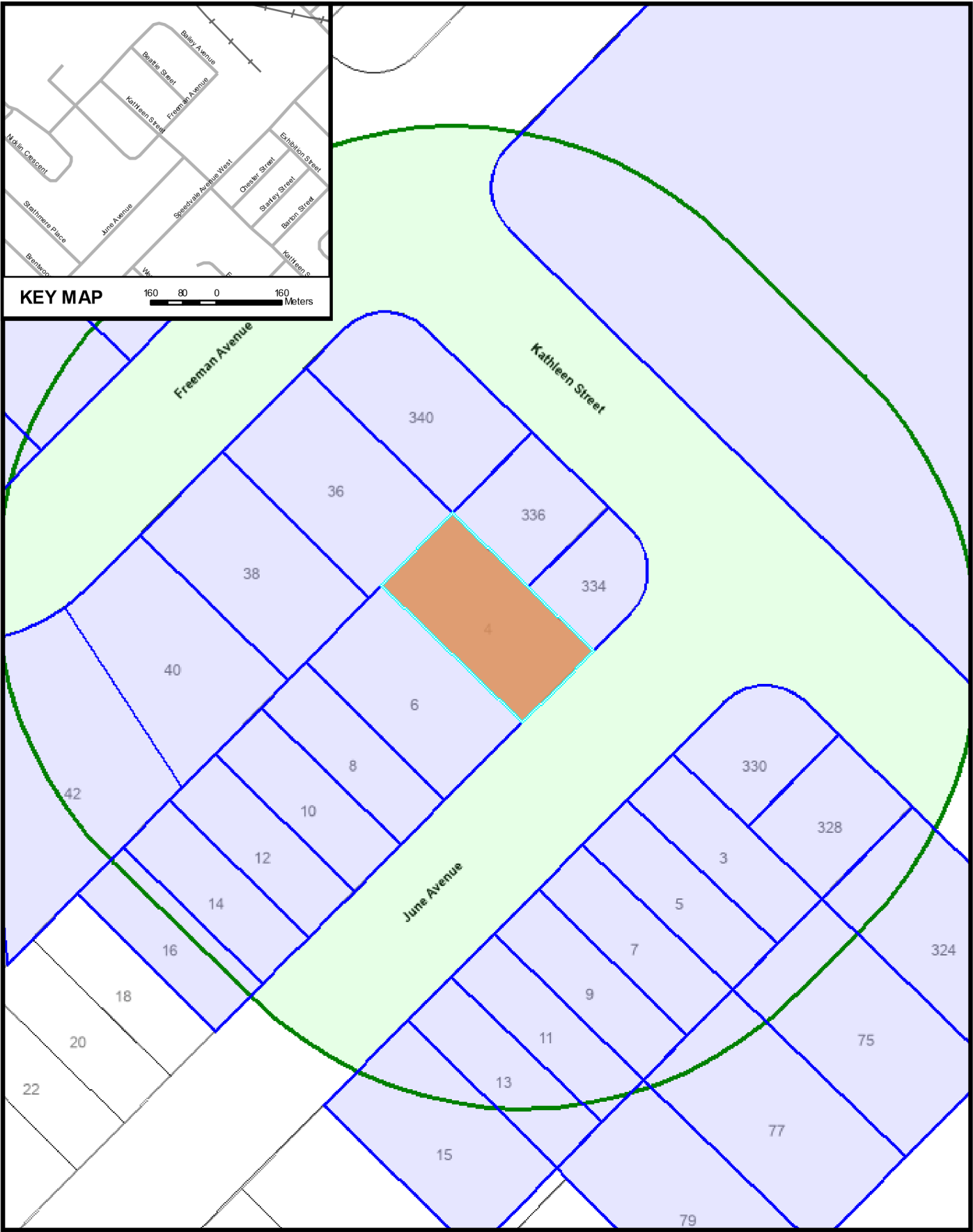
