Application for Consent [New Lot] has been filed with the Committee of Adjustment

Application Details

Location:

47 and 87 Hyland Road

Proposal:

The applicant is proposing to sever a part of the property to create a new lot with one retained lot. The proposed severed lands currently contain an existing dwelling, which is proposed to remain.

The Committee of Adjustment previously approved a consent application for this property (file B-46/24) on January 16, 2025.

By-Law Requirements:

47 Hyland Road is located in the Low Density Residential 2 (RL.2) Zone and Natural Heritage System (NHS) Zone, and 87 Hyland Road is located in the Urban Reserve 1 (UR.1) Zone, and Natural Heritage System (NHS) Zone, according to Zoning By-law (2023)-20790, as amended.

Request:

The applicant proposes to sever a parcel of land with frontage along Hyland Road of 27.4 metres, and an area of 0.14 hectares. The retained parcel will have frontage along Hyland Road of 274.7 metres, and an area of 4.34 hectares.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 53 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of

Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 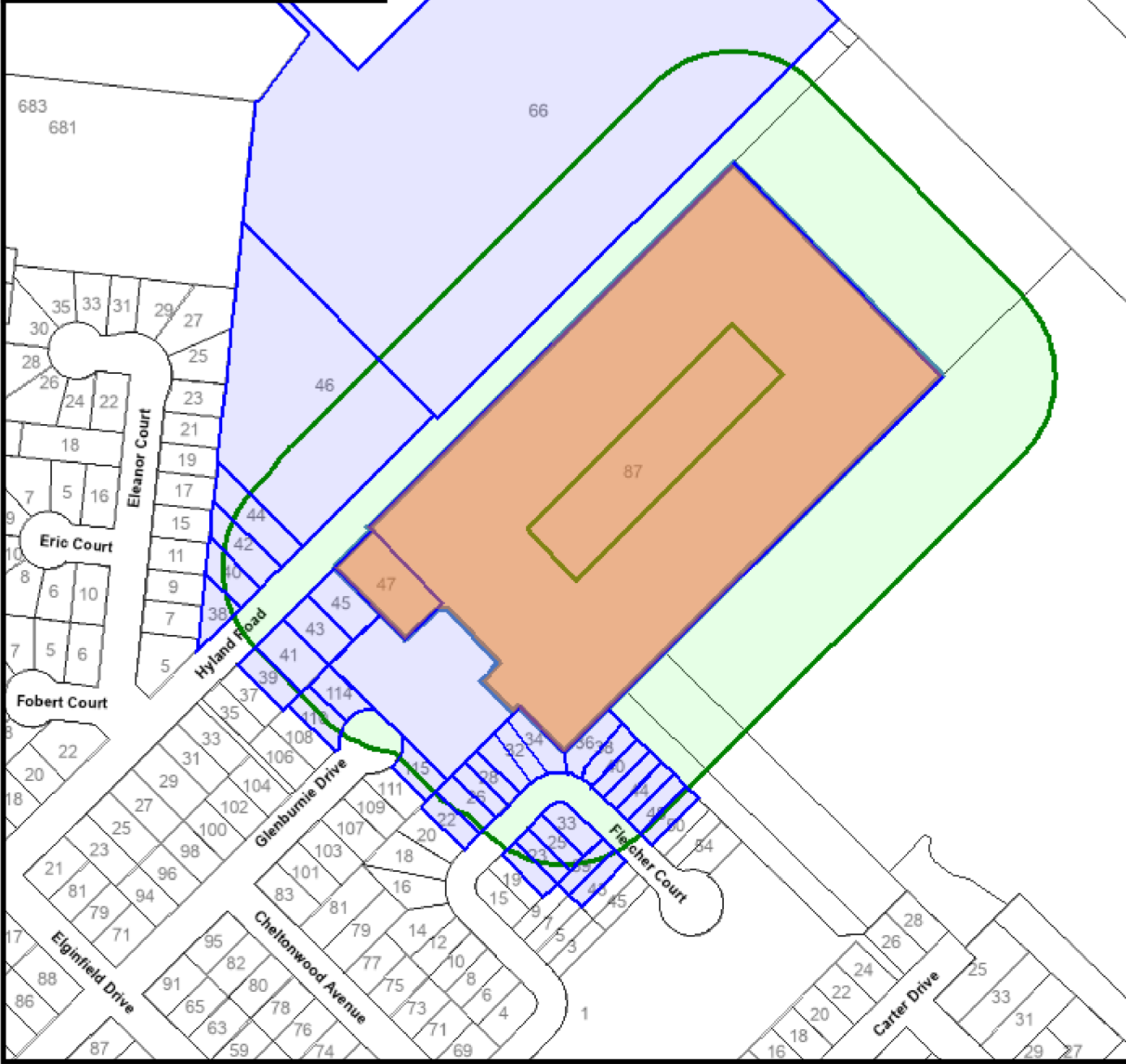
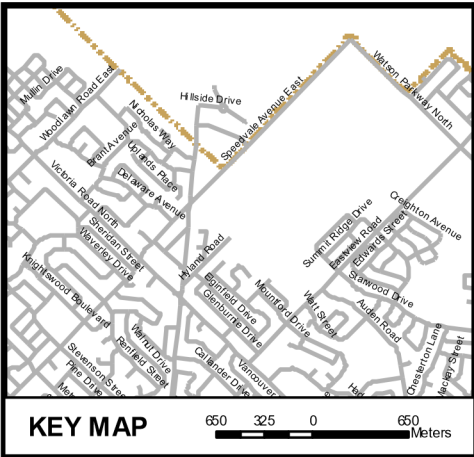
