- 2. Effective immediately, The City of Guelph to manage a Guelph Rental Housing Registry (GRHR), linking guelph.ca, to prospective Guelph renters, to kijiji.ca, thecannon.ca and mls.ca. GRHR will recommend people search the type of rental housing they want, by price. For example, Single Room, Shared Home or Apartment, Bachelor, One Bedroom Apartment, Two Bedroom Apartment, etc.]
- 3. Effective immediately, The City of Guelph to manage a charitably-funded, Guelph Emergency Doctor in Residence Program (GEDR)
- 4. Effective immediately, The City of Guelph to manage a charitably-funded, Guelph House Arrest Program (GHA)
- a) The Guelph Employment and Employment Training Program charity will be called GEET Charitable Fund b) GEET will remain revenue-neutral annually, by the City of Guelph mandating any 18 year old to 49 year old Guelph citizen that receives any Guelph Municipal Benefits (GMB's), must earn 10% of the GMB's in 2026, 20% in 2027, 30% in 2028, 40% in 2029 and 50% in 2030. - 3. a) The Guelph Emergency Doctor in Residence charity will be called GEDR Charitable Fund b) Effective January 1, 2026, GEDR intends to hire a minimum of 3 – 40 hour per week Guelph Emergency Doctors in Residence (GEDRs), 3 – 30 hour per week GEDRs, 3 – 16 hour per week GEDRs, 3 – 12 hour per week GEDRs and 12 – Relief GEDRs to cover the 12 GEDRs vacation and sick days.
- 4. The Guelph House Arrest Program charity will be called GHA Charitable Fund. Effective January 1, 2026, GHA intends to hire a minimum of one, 9 am to 5 pm, 40-hour per week employee at \$17.60 per hour, plus 4% vacation pay and purchase all the required House Arrest Ankle Bracelets to manage any new Guelph citizens who are in House Arrest.
