

The Corporation of the City of Guelph

By-law Number (2025) - 21182

A By-law to amend By-law Number (2023) - 20840, as amended, being a By-law to impose user fees or charges for services or activities relating to Parking Services.

Whereas pursuant to section 391 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended (the "Act"), a municipality is authorized to pass by-laws imposing fees or charges on persons;

And whereas for the purposes of this By-law, and as defined in section 390 of the Act, "person" includes a municipality and a local board and the Crown;

And whereas the City wishes to amend Schedule 1 to By-law Number (2023) - 20840 - Parking Services Rates and Fees;

And whereas the new and/or amended fees and charges that are imposed pursuant to this By-law were approved by City Council on November 26, 2025 as part of the 2026 Budget;

The Council of the Corporation of the City of Guelph enacts as follows:

1. Schedule 1 to By-law Number (2023) - 20840, as amended, is hereby amended as follows:

- 1) "Table 1, (Table 120) Monday to Friday hourly parking rates" is deleted in its entirety and replaced with the following:
