The Corporation of the City of Guelph

By-law Number (2020) - 20525

A by-law to move Business License Fees from the Business Licensing By-law to the Fees or Charges By-law.

Whereas

The City has previously passed By-law Number (2009) – 18855, as amended, being the Business Licensing By-law;

And whereas the City has previously passed By-law Number (2019) – 20460, being the Fees or Charges By-law;

And whereas the City wishes to amend the Business Licensing By-law by removing the Business Licensing Fees from it;

And whereas the City wishes to amend the Fees or Charges By-law by adding the Business Licensing Fees to it;

The Council of the Corporation of the City of Guelph enacts as follows:

- 1. The Business Licensing By-law is amended as follows:
 - (a) The following is added as section 1A: "Every City fee mentioned in this By-law means the applicable fee set out in the City's Fees or Charges By-law.";
 - (b) In paragraph 4(a)(ii), the words "as set out in Schedule "C" of this By-law" are deleted;
 - (c) In paragraph 5(b)(ii), the words "as set out in Schedule "C" of this By-law" are deleted;
 - (d) In paragraph 6(a)(ii), the words "as set out in Schedule "C" of this Bylaw" are deleted;
 - (e) In paragraph 17(a), the words "of \$25.00" are deleted;
 - (f) In paragraph 17(b)(ii), the words "of \$25.00" are deleted;
 - (g) In section 29, the words "as set out in Schedule "C" to this By-law" are deleted;
 - (h) Schedule "C" (Schedule of Fees) is deleted;
 - (i) Schedule "D" (Enforcement Portion of Business Licence/Renewal Application Fee) is deleted;
 - (j) In Schedule 9 (Pawnbrokers), in paragraph 2(b), the words "the sum of two thousand dollars (\$2,000.00)" are deleted, and replaced by "the specified fee amount";
 - (k) In Schedule 16 (Taxicab), in section 7(b), the words "fees under this By-law" are deleted, and replaced with the words "applicable fees";
 - (I) In Schedule 16 (Taxicab), in section 17(e), the words "by this By-law" are deleted;
 - (m) In Schedule 16 (Taxicab), in section 24(k), the words "by this By-law" are deleted;
 - (n) In Schedule 16 (Taxicab), in Appendix "C" (Taxicab Driver's License Requirements), in the initial paragraph, section 6, the words "by this By-law" are deleted; and
 - (o) In Schedule 17 (Vehicle for Hire), in section 5(e), the words "required under this By-law" are deleted.
- 2. In all other respects the Business Licensing By-law remains unchanged.
- 3. The Fees or Charges By-law is amended as follows:
 - (a) The following is added as section 2A: "Schedules C, D, and E hereto, which form part of this By-law, set out the fees and charges of the City

- for the activities and services enumerated therein."
- (b) The schedules attached to this By-law are hereby attached to the Fees or Charges By-law as Schedules C, D and E.
- 4. In all other respects the Fees or Charges By-law remains unchanged.
